Type I	Routine exam, prophylaxis
Type II	X-rays; fillings; simple extractions; palliative treatment
Type III	Biopsies; histopathologic examinations; repairs to existing crowns: dentures and bridges; recementation of existing crowns, inlays, onlays and bridges
Type IV	Endodontics (root canals); non-surgical periodontics (gum treatment); surgical extractions; extractions of impacted teeth; other oral surgery; general anesthesia and IV sedation; denture relines and rebases; denture adjustments
Type V	Periodontal Surgery; inlays and onlays; crowns; complete and partial dentures; fixed bridgework
